NUNCUPATIVE WILL: An unwritten will, have been declared or dictated by the testator in his last sickness, before a sufficient number of witnesses, and afterwards reduced to writing.

# CAPE GIRARDEAU COUNTY RESIDENTS IN TEXAS

The following information is taken from a letter written by R.W. Harris of Cumby, Texas, on September 25, 1926, to R. Burette Oliver of Cape Girardeau, MO. Mr. Oliver in turn gave a copy to the Cape Girardeau County Historical Society who has graciously allowed us to publish it in the COLIAGE.

\* \* \* \* \* \* \*

Having spent our early life in old Cape County and having noticed how often our citizens cast their eyes longingly towards the Lone Star State and finally, lured by reports of the many advantages the state possessed, they would break loose from home and kindred and come to Texas. Soon the time came when we were seized with this wanderlust and we followed in the steps of those who had preceded us here.

Knowing that many who have moved to this state, have in a measure, become lost to those back home, we felt that possibly it might interest some to know who have left Cape County for this state and what became of them.

The first one to leave Cape County for Texas of which we have any knowledge was our distant kinsman, Charles A. Harris, a son of Oliver Harris, who had assisted in the organization of the Old Apple Creek Church in 1821. This Charles Harris lived on the Mississippi River about a mile above Neelylanding. His house was on the river bank, just a short distance above Hanging Dog Rock, which stood on the lower side of the mouth of Dogcreek. In the winter of 1871, J.F. Oliver married and moved to this place and resided there for over 50 years. Charley Harris moved with his family to Hopkins County, Texas, in 1857. He raised a large family of children, all of whom are now dead. He died in 1866 and his wife died in January, 1892. Both were buried in Oakland graveyard, about 3 miles ME of Ridgeway, Texas. His wife was Elizabeth Hope, a sister of Judge David C. Hope who died July 4, 1886. Several grand children of Charley Harris reside in Hopkins County, Texas and in Rush Springs, Oklahoma.

During the Civil var, one wm. Cline came out to Hopkins County. This man came from the northern portion of the County near the Perry County line and was related to the Dr. Cline who at one time lived there. He was a cripple, in that one of his legs was affected in some way, causing him to limp in his walk. After moving to Texas he taught school for many years and was for a number of years District Clerk of Hopkins County. He later moved to Sulphur Bluff in Hopkins County where for a time he conducted a drug store, dying there a few years ago and is buried at that place.

In 1870, Delevan Sheppard, who had been quite a prominent man in Cape County, having held the office of Tax Assessor and possibly other offices, shipped his effects by boat to Jefferson, Texas, from Neelyslanding. From Jefferson he moved to Black Jack Grove in Hopkins County, where he resided several years, finally moving farther west to Collin County, where he died many years ago and is buried near Josephine in that county. His wife was the mother of Wn. Cline, mentioned above, by her former husband. Mr. Sheppard's family consisted of 2 daughters, Julia and Emma, and one son, Clay. Julia married shortly before moving to Texas to Robert F. Woods, son of James Woods pioneer settler of Leemon. When the family moved to Collins, Emma and Clay went along and Emma married there in Collins County and is still living. Clay and Mrs. Sheppard have both been dead for many years.

Along in the early 70's Fred Swan, a brother to Dick Swan of Oak Ridge, moved to Tarrant County and located near Arlington. He raised a large family, most lived in Arlington. One of the Days, a brother to Nick Day who lived at Oak Ridge and one of the McLane's, a brother to Jas. W. and Marion McLane of Oak Ridge, also located in Arlington in the 70's.

In 1871 Robert Wood and his wife (nee Julia Sheppard, who were married in Cape County) moved to Texas and located near Black Jack Grove, where Mrs. Sheppard's parents were. Shortly after, Joe Woods, Miss Bettie Woods, and a sister, Mrs. Duncan, with their father, Uncle Jimmie Woods all moved to Hopkins County.

J.C. Statler, a son of Uncle Wiley Statler, who was one of the pioneers of Oak Ridge, came to Texas along between 1872 and 1876 and located at or near Sherman, Texas. He died from injuries received in a fall on the ice. This J.C. Statler was for many years engaged in General Mercantile business at Oak Ridge with the late Lewis Hinkle.

Nick Wilson, a brother of Sandy H. Wilson of Oak Ridge, came to Texas in early 70's and engaged in the dry goods business at Pilot Point in Denton County. He died some 8 to 10 years ago, buried at Pilot Point.

Wm. Flinn, a son of Ebenezar Flinn and a brother to Uncle Andrew Flinn, came to Texas along about 1854 or 56 and settled near Paris in Lamar County, but about 1860 he moved his family to California. He has one daughter living in San Bernadino. She is 87 years old.

Brooks Horn, brother to Mrs. M.J. Hays (dec'd) and an Uncle to Will and Dave Hays of Jackson came to Texas and located in Dallas about 45 years ago. He died a few years ago and had several children now living in Dallas.

Dave Hahn of Oak Ridge who married a daughter of Wm. Clippard, with his daughter, Nola, moved to Arlington, Texas, about 1889 and there in the summer of that year, Tom Swan, a son of Dick Swan of Oak Ridge, and Miss Nola Hahn were married.

About the middle of the 80's, Wm. Baldridge, brother to the late Dr. John M. Baldridge went to Texas and located at Midlothian in Ellis County, he died there and was buried there.

In February, 1882, Jas. H. Thompson left on a boat from Neelylanding for Texas. He stopped at Richardson, in Dallas County, and engaged in the mercantile business. After the death of his wife he retired. He died some five or six years ago and is buried there. His wife was a Hansel, sister to John Hansel of Fruitland. His son Bob, who was born near Neelyslanding about 1878, still lived in Richardson. John Hansel later moved to Richardson. He had married Miss Ellen Caldwell of Fruitland who died many years ago and was buried at Richardson. John Hansel is also dead and I understand he is also buried at Richardson, although he died in Dallas.

In 1885 J.H. VanAmburg (known as Harvey) son of John VanAmburg, south of Jackson, moved to Texas and was employed in the city schools of Greenville for nearly 20 years. He retired from teaching and conducted a fire insurance agency for years. He died 7 or 8 years ago and is buried in Greenville. His wife and 2 sons moved to Dallas.

When Jas. H. Thompson came to Texas, Tom Trickey, son of Tom Trickey of Indian Creek, came with him and stayed several years, but have lost track of him.

Long prior to the coming to Texas of Wm. Baldridge, his daughter Ann and his daughter Mollie came to Texas and I understand they live near Midlothian.

Alfonso Wilson, a farmer near Shawnee town, had a daughter who married a man named Clouse and for years lived in St. Louis. After the death of Mr. Clouse, his wife married a man named Dr. A.M. Elmore and they moved to Dallas. He was at one time the City Health Officer of Dallas. He died several years ago, but Mrs. Elmore and 2 daughters by Mr. Clouse still live at Dallas.

More than 50 years ago a family living on the main road between Leemon and Pocahontas was named Hill. The older members are long since dead, but some of the young ones still live in Denton Gounty, near Pilot Point.

On the road leading South from Pocahontas at a point where the road crossed a small creek lived a family by the name of McFarlin. The elder Mr. McFarlin died and his widow married a man by the name of Hays, the father of Joe Hays who was jailer at Jackson, hissouri. Mr. Hays and his new wife moved to Texas and he died in Hopkins County and was buried in Peerless Cemetery, some 12 miles north of Sulphur Springs. This all occurred prior to when this writer came to Texas, but a Mr. McFarlin, a son of the old man lived near Pocahontas and told me of this years ago.

John W. Ruff, a pioneer of Fruitland and Pocahontas had a daughter named Elvira who married her cousin, George W. Ruff. In the early 80's they moved to New Boston in Bowie County where Mr. Ruff sold goods. He died there 1909 and is buried in Mt. Reid Cemetery about 3 miles south of there. Mrs. Ruff still lives with her daughter in Leonard, Texas. Her daughter married a Dr. named Crabb. It is said Mrs. Ruff's father was the first person buried in the Shiloh Cemetery 2 miles south of Pocahontas.

Rev. C.W. Alexander, a Presbyterian minister, came to Texas in middle 80's and died in Midlothian.

Charley Ingram who lived at Shawneetown, in a house later owned by L.E. Torrence and later by Rev. Killough and who married a young lady by the name of Mollie Johnson, moved to Texas years ago, but his wife is dead and I have lost tract of him.

Calvin Adams, at one time a large land owner and one of the most prominent citizens of Apple Creek township, living near Shawneetown, left Cape County in 1882 and finally after several years landed in west Texas. He passed through Hopkins County some 25 years ago and spent a day or two with John E. Harris and family, at that time living at Ridgeway, Texas. He decided not to locate here and went west again. He died many years ago. Several years ago, the writer had a letter from one of Mr. Adams sons, living at that time with his Mother at Joplin, Mo. Mrs. Adams has since died and is I think buried at Joplin, Mo. Mrs. Adams was a sister to Alfonso, Rich and Addison Wilson, all prominent men living around Shawneetown at one time. I also think a Miss Johnson, a sister to Mrs. Wm. Green of Jackson still resides in or near Sherman.

Ed Wilson a son of Alfonso Wilson went to Texas about 1886 and located at Pilot Point where he engaged in the dry goods business with his Uncle Nick and soon acquired a competency. He later located at Denton, then later moved to California.

Martha, daughter of Ebenezar Flinn, in 1844 married a man by the name of Henderson and moved to Louisana. She returned to Cape Co. in 1883 to visit her brother, Uncle Andrew Flinn. Before the Civil War her husband moved to Texas, settling near Terrell. She died there many years ago. She had a son W.E. Henderson living near Terrell and one named Charley residing at Gordon, Texas.

Wm. Byrd of Jackson (formerly) moved to Uvalde, Texas. He died a few years ago and

was returned to Jackson for burial. His sons still live at or near Uvalde. David Glenn formerly of Cape Girardeau, now resides in Dallas with his son.

Joe E. Harris, one time citizen of Neelyslanding, moved to Hopkins County, Texas, in March, 1892. He located at Ridgeway, where with Jas. P. NcNeely, now of Fruitland, Mo., he sold goods until January, 1907, when he moved to Malta, in Bowie County where he died March 17, 1908. He is buried in the Mt. Reid Cemetery near the grave of George W. Ruff. His wife, who was daughter of A.G. McNeely of Cape County, died in November, 1917, and is buried in Mt. Reid Cemetery near New Boston, by her husband.

C.B. Johnson who married in 1882 to Mrs. Sarah McNeely, daughter of Elisha Sheppard moved to Jack Grove, Texas, in March, 1892. In July moved to Columbia, Mo., where he died five years ago. His widow lives at Sam Marcos, Texas, with her daughter Lillie, who married a man named Thomas. His daughter Isabelle has never married and is a teacher.

Charles Landis, who was raised near Oak Ridge and who for many years was a salesman for Hinkle, Statler & Co. went to Texas in 1886 and located in Limestone County. Later he went out on the plains and was a cowboy. Later he held several county offices and is now Justice of Peace of the city of Amarillo. He is known as Judge Landis.

L.G. Wilson, called Green, son of Uncle Sandy Wilson of Oak Ridge, studied law under Senator R. Burette Oliver in the mid 80's, admitted to the bar and came to Texas about 1887 or 88 and located at Plainview, in Hale County.

Tom Wilson who 40 years ago was one of the prominent school teachers in Cape County and who was at one time county superintendent married Miss Nora Davenport, a daughter of Joe Davenport of Oak Ridge. They came to Texas in later 80 s and taught school for a time at Arlington, in Tarrent County. Later he moved to Paris in Lamer County and later moving to the Indian Territory where he died. His wife moved back to Cape County and married Jacob Doyle, dying a couple years ago.

Prof. Brooks (I think his initials were W.A.) a brother to Charley Brooks of Neelyslanding and a son of Jas. Brooks who lived at Egypt Mills, taught school in Dallas for 20 years, dying there a couple years ago.

Over at Mineral Wells there is a Dr. Thompson, who was the son of Gus Thompson who was a farmer at Egypt Mills.

Cyrus E. Alexander, a son of a Methodist Minister and a nephew of Rev. C.W. Alexander, located in Denton County in the mid 80's. He afterwards went to Midlothian dying more than 20 years ago.

E.G. Holden from Oak Ridge and Fruitland area, came to Dallas in 1887 where he still lives. He is now a granddaddy.

Will Hays and John T. McNeely both moved to Texas in 80's, but both had sweethearts that drew them back to Cape County.

One of the Ponders from Cape Girardeau moved to Denton County and a daughter married a Belo, a son of the founder of Dallas News. Belo is dead, but his wife (nee Ponder) still lives there. (I think is a director of the Dallas newspaper.)

Thomas P. Onstadt, son of Mike, who lived south of Applecreek, and who was raised by John E. Harris, came to Texas in 1891. He died in Dallas in November 1906 and is

buried there. Charley Onstadt, brother to Tom, was raised by Calvin Adams and when Calvin Adams left Cape County in the fall of 1882 and went to Wayne County, Mo., Charley went with him. He reached Texas in the spring of 1894 and lived around Black Jack Grove for many years. In 1908 he located in Bowie County and owns a farm near Malta, where he is passing his declining days. He was never married, but lives with the party who rents his farm. He is past 66 years old.

"B.F. Lusk who was raised near Egypt Mills and who later ran the Herald newspaper in Jackson now resides in Dallas. He married Emma Sawyer, daughter of Judge John J. Sawyer of Fruitland.

L.F. Cowan, called Pomp, came to Hopkins County in 1892 and taught school at Pickton and Sulpher Springs. He later moved to Colorado and has for the past 20 years or more resided in Denver, Colo.

Walter Morton, son of Grantz Morton, of the Fruitland area moved to Texas and settled wat Longview where he died a few years ago. He is buried at Longview in Gregg County. the state of the state of the state of the state of

L.P. Ruff, Jr., son of L.P. Ruff, dentist at Jackson for 40 years, came to Texas about 1905 or 6 and was a salesman for Simmons Hardware Co. of St. Louis. He made his home at Dallas with his widowed mother. He died when the Missouri Athletic burned . i .. in St. Louis years ago.

Walter Hancock married Cora Young lived for years at Texarkana, Texas. His wife was the daughter of Jim Will Young who lived near McLains Chapel on Indian Creek. e e kaderate, his a fito do lo safa, his e in the state of the page

E.F. Bloomeyer married a daughter of Dr. Sam S. Harris a Doctor at Cape Girardeau, lived for years at San Antonio, but now lives at Toledo, Ohio.

Robert E. Harris, son of Elam W. of Neelyslanding moved to Texas in the fall of 1892. He now lives at Rush Springs. Okla. where he is in the lumber and coal business.

Lee Hart, son of W.K. Hart of Oak Ridge, lives near Lissie in South Texas.

A son of Emory Harris and grandson of late Oliver S. Harris of Oak Ridge, lives in Houston, Texas where he is a Doctor.

CAPSULES OF WISDOM

He made his money the old-fashioned way----he inherited it. Farmers' Almanac, 1984

IN THE NAME OF GOD, AMEN:

I, William Fulbright, of the County of Lincoln and State of North Carolina, being in a poor state of health, though in perfect mind and memory, Blessed be God, Therefore do this Thirteenth day of February in the year of our Lord One Thousand Eight Hundred and Five, Make and publish this my Last Will and Testament in manner and form following, that is to say: I commend my soul into the hands of God Almighty who gave it to me, and my body to the earth from whence it came to be buried in a Christian like manner at the discretion of my Executors hereinafter named, in hopes of a joyful Resurection through the merits of my Blessed Saviour Jesus Christ, and for that worldly state wherewith it has been pleased God to bless me, I dispose of in the following manner (to wit)

That all my just debts be first paid.

Item: Then I give and bequeath unto my Beloved Wife Christinah Fulbright, use of my plantation with my Horses Cattle Sheep and Hogs, together with all my household goods plantation tools and other utensils during her natural lifetime or widowhood, but if she marrieth, to have her featherbed and furniture, one cow and calf, one iron pot of her own chusing, and one spinning wheel, and no more.

Item: I give and bequeath to my beloved son Jacob Fulbright the plantation whereon I now live and all that tract of land to him the said Jacob Fulbright his Heirs and assigns forever, after my well beloved wife Christinah Fulbright's death or widowhood, and Thirty pounds of gold or silver into my estate for the above mentioned land, to pay fifty pounds a year, yearly and every year after our deaths till paid, the first payment to be made one year after our deaths.

Item: I give and bequeath unto my two grandchildren, Peter and Elizabeth Fulbright, son and daughter of George Fulbright deceased, the sum of one shilling sterling each.

Item: I give and bequeath unto Margaret Cawwe wife of John Cawwe, one shilling sterling.

Item: My further will is that after my well beloved Wifes death or widowhood, that all and singular of my personal Estate with the two hundred pounds before mentioned be equally divided between my eight children, Jacob Fulbright, John Fulbright, Catherine Bullinger, Elizabeth Killian, Dorothy Moyers, Christina Tayler, Mary Link and Margaret Crites. My further will is that those of my children that hath received part of their legacy or portion shall be counted in with what is now coming to them so that what some of them hath already received may make them equal with those that hath received no part.

And I do make constitute and appoint my two well beloved sons, Jacob Fulbright and Benjamin Taylor to be my whole and sole Executors of this my last will and testament, disallowing and making void all other will or wills by me heretofore made, Ratifying and confirming this my last will and testament.

In witness whereof, I the said William Fulbright, have hereunto set my hand and seal this day and year first above written.

ANNOUNCEMENT

CHANGES IN PROCESSION REQUESTS FOR COPIES OF VETERNANS' RECORDS AND PASSENGER ARRIVAL RECORDS

Effective Nay 1, 1984, all requests for copies of military service records or passenger arrival records must be submitted on NATF Forms 80 and 81, respectively.

After May prior versions of these forms (NATF Form 26 and NATF Form 40) will not be accepted for processing. All forms other than the NATF Form 80 or NATF Form 81 that are received after May 1 will be returned.

A change in payment policies will also take affect May 1, 1984. NARS has in the past required that payment accompany requests for copies of veterans records and passenger arrival records. After May 1, 1984 payment should not be sent with the NATF Forms 80 and 81. NARS will research the request, prepare copies of any records located, and HOLD THE COPIES for 30 days or until payment is received, which ever is sooner. As soon as records are located and copied, researchers will receive a bill and instructions on returning their remittances.

Researchers should also submit a separate NATF Form 80 for each file (pension or bounty-land or compiled military service) desired. Previously researchers could ask for multiple files on one form. This change is designed to facil tate processing by the National Archives. Any one interested in obtaining copies of the NATF Forms 80 or 81 may do so after April 1 by writing to the following office:
